The Commission resolved to:

- 1. Note that the appropriate level of assessment for the marina development has been previously set as an Environmental Impact Statement (EIS), which was prepared in 2006, and that an Amendment to the EIS process is now being undertaken to facilitate the inclusion of two new components (Holiday Village and Water Park), pursuant to S.47 of the Development Act 1993);
- 2. Note that the settled draft Guidelines will be provided to the Environment Protection Authority (EPA) for consultation, pursuant to section 46(10) of the Development Act 1993;
- 3. Approve the attached draft Guidelines and the ranking of assessment matters for the proposed Holiday Village and Water Park, with any amendments as agreed by the Commission;
- 4. Delegate to the Chair the role and function of finalising the Guidelines following receipt of advice from the EPA, including signing the attached letter (as amended to note that as required, advice



was sought from the EPA) to the Minister for Planning advising him of the Commission setting the Guidelines;

- 5. Note that the agenda report, attachments and minutes of this meeting will be provided to the Minister for Planning as evidence of the Commission's decision pursuant to section 46(12) of the *Development Act 1993*; and
- 6. Note that following the above steps, the Minister will provide the Guidelines to the proponent and make them available to the public on the SA Planning Portal.

Seek the approval of the Minister for Planning pursuant to section 29(1)(c) of the *Planning, Development and Infrastructure Act 2016* ('the PDI Act'), to form a specialist sub-committee for the provision of heritage advice to the Commission for the period of two years on Development Plan Amendments (DPAs) under the Development Act 1993 and Planning and Design Code Amendments (Code Amendments) under the PDI Act;
- 2. Seek the approval of the Minister for Planning of the draft Terms of Reference (as amended) for the proposed Heritage Sub-Committee;
- 3. Write to the Minister for Planning recommending that the Minister delegates the approval of these SOIs to the Commission;
- 4. Delegate the finalisation of the draft letter and Terms of Reference to the Commission Chair to send to the Minister; and
- 5. Note that the department will return with advice on the composition of the sub-committee following approval from the Minister for the establishment of the sub-committee.
