### PEREGRINE MIXED USE MAJOR DEVELOPMENT VARIATION 2

### RELEASE OF A PUBLIC ENVIRONMENTAL REPORT FOR PUBLIC COMMENT

On 16 May 2017 the Governor granted Development Authorisation for the Peregrine Mixed Use Major Development at 270 The Parade, Kensington, comprising the demolition all existing structures on site and construction of a new seven storey mixed use building.

On 27 September 2018 the Minister for Planning varied the Major Development declaration to capture activities and works associated with a Helicopter Landing Facility (Variation 2) pursuant to Section 46 of the Development Act 1993.

The proponent (Shahin Enterprises Pty Ltd trading as Peregrine Corporation) lodged an application for Variation 2 on 15 October 2018 with amended plans provided on 23 November 2018.

On 14 December 2018 the State Planning Commission (SPC) determined that the proponent must prepare a **Public Environmental Report** (PER) in respect of the proposal and issued assessment guidelines outlining the key issues which the PER must address.

The proponent has now prepared a PER in response to the Guidelines.

The delegate for the Minister advises, by way of this notice, that the PER is released on public consultation from 29 January 2020 until 13 March 2020.
