<u>Proposal</u>: Port Augusta Renewable Energy Project – Stage 1 – variation to current authorisation: to increase the maximum tip height of wind turbines from 150m to 185m (comprising increases to rotor diameter, hub height, and turbine capacity). The overall number of wind turbines will be reduced from 59 to 50 WTG machines.
