Recommendation

The purpose of this report is to provide an update on any matters relating to the SCAP that the Commission should be aware of between the period of 1 August 2021 and 30 September 2021.

Workshops/Forums

As advised in the last SCAP update report before the Commission on 19 August 2021, the Attorney-General's Department will be providing workshop sessions to SCAP members on various topics.

On 8 September 2021, the first workshop (presented by Jason Cattonar, Brett Miller and Jason Bailey) on *Code Mechanics & Performance Assessed Development* was held. It was an informative and interactive workshop.

Future workshops are proposed in coming months in relation to Restricted Development and Environmentally Sustainable Development (ESD).

The SCAP is also proposing to host an Industry Feedback Forum in mid-November 2021. These sessions have been held previously and are a good opportunity to gain feedback from people within the industry who regularly interface with the SCAP, as well as an opportunity for SCAP to offer advice on what is useful to SCAP deliberations and the interpretation of proposals. The SCAP would welcome attendance at the forum by Commission Members should they wish to attend.
