I refer to your application to the Office of the Minister for Transport, Infrastructure and Local Government, Minister for Planning made under the *Freedom of Information Act 1991* (the Act) which was received 17 July 2019.

You have requested access to:

"A copy of any current document which lists all staff and/or job titles in the Minister's office, including department staff appointed to the Minister's office AND a copy of the current Confidential Ministers' Directory."

A search of documents held by the Office of the Minister for Transport, Infrastructure and Local Government, Minister for Planning was undertaken. I wish to advise that 1 document has been identified within the scope of your request.

Please refer to the attached schedule that describes the document and sets out my determination and reasons in summary from.

I have determined to grant partial access to document 1, I have removed the personal contact details within this document, determining it is exempt in accordance with clause 6(1) of the Act which states:

6-Douments affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

Attached is an explanation of the provisions of the Act which details your rights to review and appeal this determination, and the process to be followed.
