Port Lincoln Intersections Safety **Upgrade Project**

As part of the Roads of Strategic Importance (ROSI) program, the Australian and South Australian governments have jointly committed \$51.25 million (80:20) to deliver improvements to the Eyre Peninsula Network roads expected to be impacted by the closure of the Eyre Peninsula rail network.

The Roads of Strategic Importance (ROSI) program aims to deliver improvements to freight movements, safety, connectivity and support regional economic growth.

This funding includes the upgrade of key intersections and junctions along the Lincoln Highway through central Port Lincoln.

Locations include:

- Flinders Highway/Light Street and Lincoln Highway/Hallett Place;
- New West Road/Lewis Street and Hallett Place;
- Hallett Place/Liverpool Street and Adelaide Place: and
- Liverpool Street and Mortlock Terrace/Bligh Street.

Why are these upgrades planned?

The Lincoln Highway is the key road link between Port Augusta and Port Lincoln, as well as for freight to and from the port of Port Lincoln. Passing through the City of Port Lincoln, this road is not only a key transport link, but it is also an important place, with local businesses, offices and recreational destinations nearby that generate pedestrian and cycling traffic.

Conflicts between people walking and cycling and freight vehicles, cars, caravans and commuters results in traffic management issues along the corridor and detract from the safety of people walking and cycling within the city.

In conjunction with the City of Port Lincoln, the proposed upgrades seek to:

- improve road safety for all users at the intersection,
- improve pedestrian accessibility;
- recognise the dual function of the Lincoln Highway: as both a main street and a key freight
- · meet the objectives of the future City of Port Lincoln Main Street Master Plan:
- renew the pavement along the main street (Lincoln Highway and Liverpool Street) and nearby locations in the centre of Port Lincoln, including the car parking bays.
