## **New Adelaide Aquatic Centre**

Construction update – January 2024 Upcoming detour and works



The South Australian Government is designing, building, and operating the new Adelaide Aquatic Centre at Pardipardinyilla / Denise Norton Park (Park 2) in the Adelaide City northern Park Lands.

#### What's happening:

Site establishment and early works are progressing onsite from late January 2024. Activities will include:

- Creation of the construction site access via Jeffcott Road
- Start of the bulk earthworks to prepare the site for the construction of the pools and buildings and the installation of the piles to support the buildings
- Service infrastructure activities.

Piling activities will then start in late February 2024.

### How this affects you:

To ensure the safe separation of pedestrians, cyclists and workers, the north-south shared use pathway along Jeffcott Road (part of the Park Lands Trail) will be temporarily closed between Bus Stop 7 and Barton Terrace West from 29 January 2024.

The pathway is planned to reopen when the new centre opens in the summer of 2025/26. Please follow local detour signage (see map over the page for more information about planned detour).

Some traffic disruption may temporarily occur on Jeffcott Road whilst the works take place. Traffic management measures will be put in place to ensure everyone's safety.

Some noise and dust may be noticed as the bulk earthworks commence. A range of control measures will be used including noise monitoring, watering of work areas, and covering of soil stockpiles, where appropriate.

Works will be between the hours of 7am to 7pm in accordance with Environmental Protection Agency requirements.

The Adelaide Aquatic Centre car park entry and exits off Jeffcott Road will remain open until the existing centre closes on 1 August 2024.

Bus stop 7 will remain in place to provide access to the current Aquatic Centre.

# Park 2 Pedestrian and Cyclist Pathways detour 1 – 29 January 2024 until 31 July 2024.

- Pedestrians and cyclists travelling north-south along the shared use path will be redirected onto the Park Lands Trail that runs diagonally between Fitzroy Terrace and the corner of Prospect Road/O'Connell Street. This will become the primary route for commuters walking or cycling to and from North Adelaide and the Adelaide CBD.
- Path closure and wayfinding signage will be installed in Park 2 and on Jeffcott Road, Fitzroy Terrace, Prospect Road and Barton Terrace West to redirect pedestrians and cyclists.
- Cyclists are encouraged to use the existing road bicycle lanes on Barton Terrace West to connect with the Park Lands Trial at the Prospect Road/O'Connell Street intersection.
- Pedestrians are encouraged to use the existing pedestrian footpaths on Barton Terrace West to connect with the Park Lands Trail at the Prospect Road/O'Connell Street intersection.
